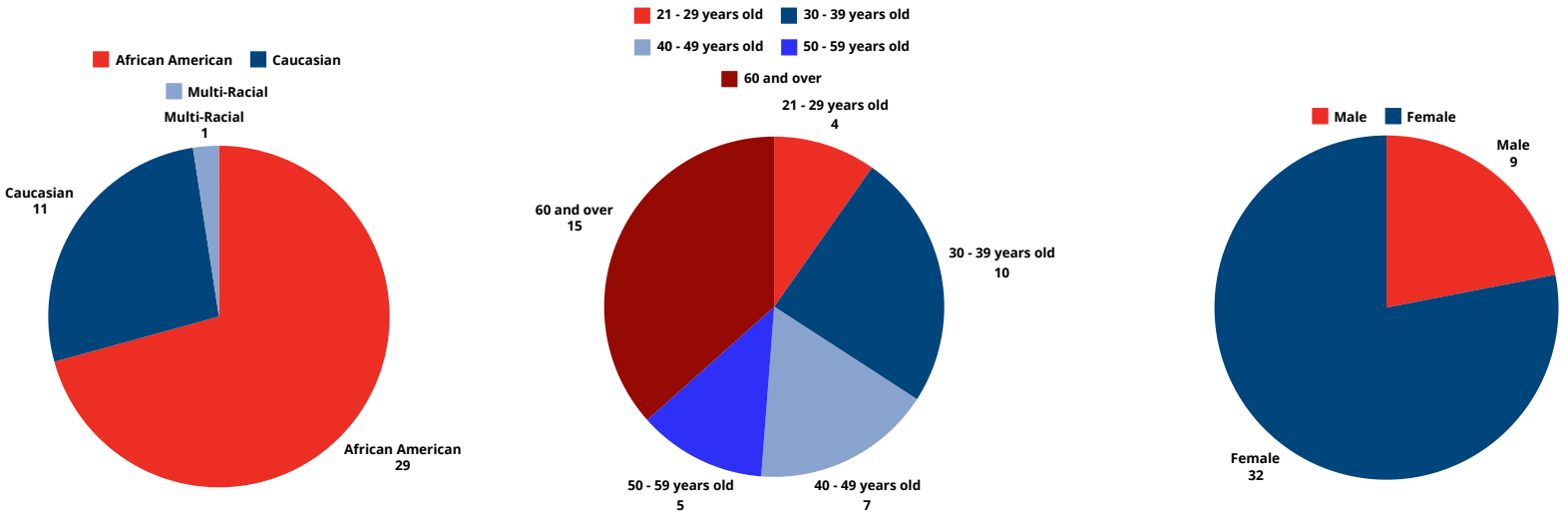

# Children Served

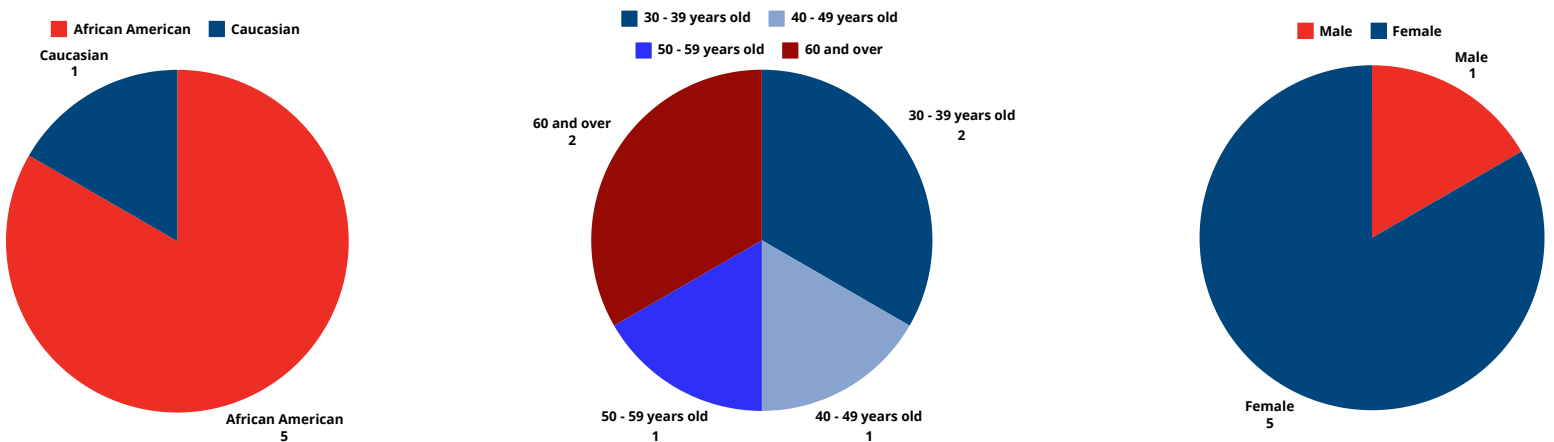

# Volunteers

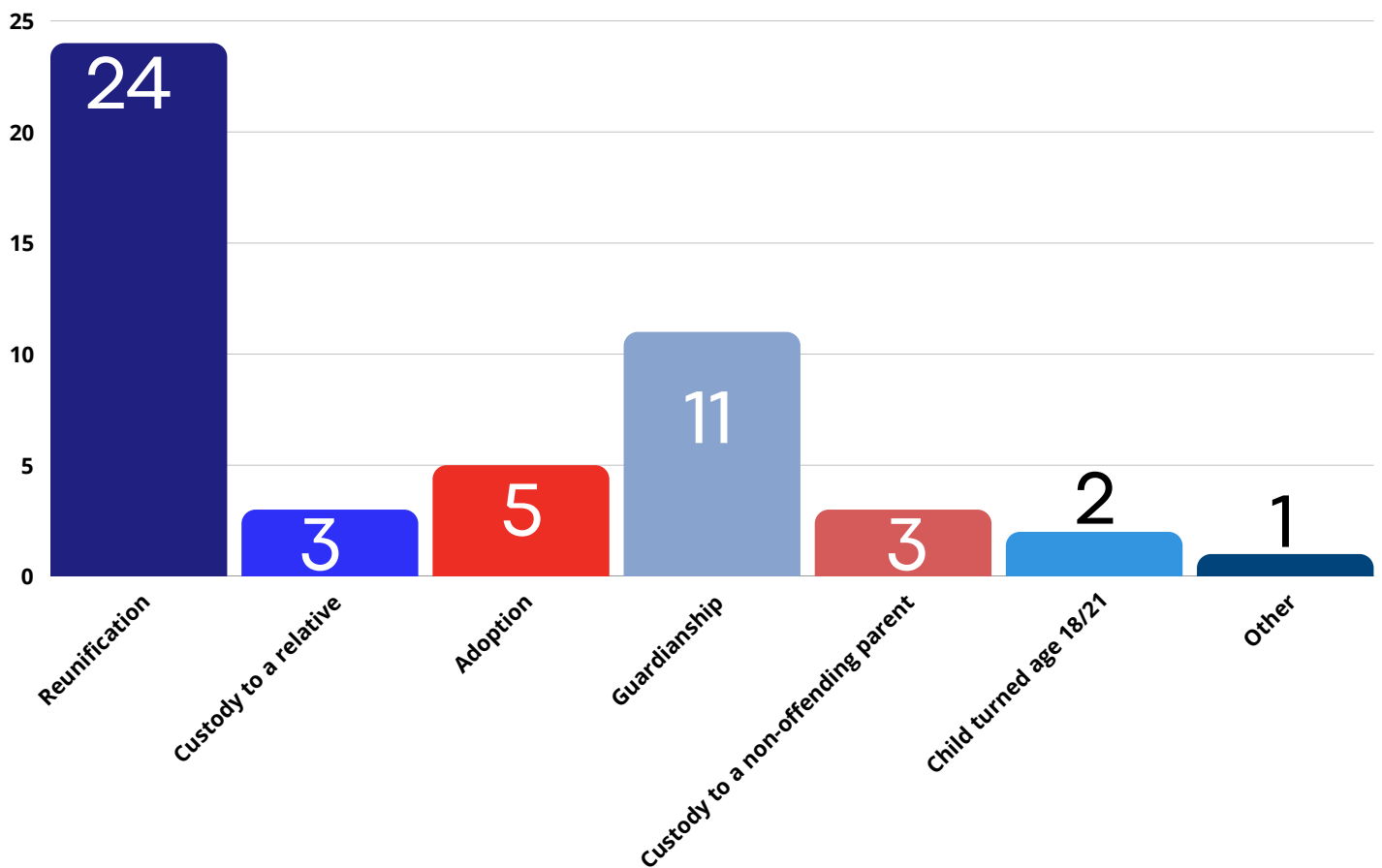
From July 1, 2023–June 30, 2024, CASA of St. Landry-Evangeline, Inc. had 41 (**14 CASAs in Evangeline Parish and 27 in St. Landry Parish**) volunteers assigned to cases with 6 new volunteers being sworn in.



# Case Closures

## Reasons for Case Closures

Between July 2023 and June 2024, CASA of St. Landry-Evangeline, Inc. successfully closed 49 cases, with 49% resulting in family reunifications.
